# MAJOR IN LAW & AMERICAN CIVILIZATION

## Requirements

Majors must complete 54 units. The program is divided into four parts, and writing skills are emphasized throughout.

- First, students must complete two introductory courses, one each in political science and economics, which acquaint students with the nature of law and its role in American society.
- Second, students will take four required courses: one at the lowerdivision, two at the upper-division level and an advanced writing course. These courses further situate students in American culture, politics, judicial policymaking and logical thinking.
- Third, students will have several options in choosing electives, which will be offered by several departments: Accounting, Mass Communication and Communication Studies, English, History, Philosophy and Religious Studies, and Political Science.
- Fourth and finally, students will undertake a 6-unit capstone
  experience of their choice and, if possible, design. Advanced students
  may wish to undertake a project in the workplace and then write an
  evaluative essay on that experience as it fits into the overall program.
  Other students will participate in a senior seminar, in which they will
  write a research paper on some aspect of the law or develop a thesis
  supervised by the program director. Finally, qualified students may
  choose to write an honors thesis.
